IT IS ORDERED that:-

1. Leave be granted to the Plaintiff to serve the following documents:-
 - (i) the Notice of Appeal (“**Intended Appeal**”), in relation to which leave to appeal to the Court of Appeal was granted by The Honourable Mr. Justice Anthony Chan on 23 August 2023; and

(ii) the Order herein,

on the Defendants by way of substituted service, by (a) publishing copies of the aforesaid documents on the webpages of the Hong Kong Police Force, the Department of Justice and the Government of the HKSAR (“**Government**”); (b) exhibiting securely at a conspicuous place that is accessible by the public at the Wan Chai Division Report Room, No.1 Arsenal Street, Wanchai, Hong Kong a notice containing the QR code linking to the aforesaid documents; and (c) issuing a press release by the Government in which the three aforesaid webpages are set out and the QR code linking to the aforesaid documents is provided;

2. The time for service of the Notice of Appeal on the Defendants under Order 59 rule 4(1) of the Rules of the High Court (Cap. 4A) be extended to 7 days from the date hereof;
3. Notice of setting down of the Intended Appeal under Order 59 rule 5(3) of the Rules of the High Court (Cap. 4A) be given by the Plaintiff by way of publishing the same on the webpages of the Hong Kong Police Force, the Department of Justice and the Government; and
4. There be no order as to costs of the Ex Parte Summons.
